

NURSING ASPECTS

OF WOUND MANAGEMENT

Background

Wounds are one of the most critical yet difficult challenges in the treatment of patients. Not only do wounds and their treatment cause patients considerable pain and suffering, but they may delay recovery and rehabilitation, and in many cases, are associated with deterioration in the patient's general health. In order for medical teams to improve the quality of wound treatment, they must understand the mechanism of wound development, the factors that affect and delay wound healing, identify at-risk patients and display knowledge of various treatment modalities.

Main Objectives

To acquire knowledge and improve clinical skills in preventing and treating various types of wounds

To gain exposure to multi-disciplinary approaches to the treatment of wounds

To become acquainted with new technologies for treating wounds

She has extensive experience in many nursing and nursing management fields and undertakes management, organizational and educational roles at Sheba Medical Center and in Sheba's rehabilitation hospital.

Ruhama was responsible for developing information systems in the area of wound management per the mandatory standards of the JCI and the Ministry of Health. She was also involved in developing and implementing the "wound care management" course in the distance learning system, which included determining the professional competence standard required in each department.
